- 2. Social Committee: Simmons Ridge annual barbecue this fall. There is a Simmons Ridge Facebook page which is not maintained by the HOA.

Old Business

- 1. Dog Waste Clean Up continues to be a problem with people cleaning up after their dogs. If you are caught a warning will be issued and repeated offensive will result in a fine.
- 2. Bus Stop Elementary bus will be coming into the neighborhood soon. The buses for the Middle and High Schools will not come into the neighborhood.

Safety evaluation was done and we were advised that cars should be parked 30 feet from the stop sign and cars should be parked on the left side of Simmons Ridge Rd. in both the mornings and afternoons.

- 3. Trash Collection removing from future agendas as there was not enough interest.
- 4. Common Area Improvements bring ideas to the budget workshops.
- 5. Street Lights: Three lights were recommended however the members not interested in the third light to go near lot 26/27. It was decided by members for Board to vote on remaining two lights one at the corner of Cottontail Run and the second one across from lot 10/11. Motion was made to approve the two lights and the motion passes 2 to 1.

New Business

Gravel path near gazebo has a busted pipe, cost less than \$50. Board voted unanimously to repair.

Trees in front of non QBH home across from lot 12, are diseased & spreading disease. Asking for volunteers and chainsaws to cut down 10 more. Walking path near gazebo is cracking. Will put on agenda at budget meeting on how to properly fix it.

Top part of gravel square – Any ideas bring to budget workshop. Thoughts on putting down more gravel vs seed. Voted to handle at next HOA meeting in November.
